**Rebate Program Terms and Conditions**

- Applicants are required to live in the designated grant eligibility area as shown on the attached map.
- Applicants must reside in a single-family home, townhome, condominium, manufactured home or business in which the washing machine will be replaced.
- Applicants may apply for the **\$350** rebate only once for each residence.
- The washing machine must remain in the possession of the original purchaser or at the original installation for at least five years, or until the washing machine is non-operational, whichever occurs first.
- The washing machines must be purchased new.
- The washing machines must be **Energy Star Certified** and have the Energy Star label ([https://www.energystar.gov/products/appliances/clothes\\_washers](https://www.energystar.gov/products/appliances/clothes_washers)).
- The customer is solely responsible for the purchase, installation arrangement and payments for the washing machine.
- The receipt and invoice for the appliance must be dated after March 23, 2017 and submitted with your application. The proof of purchase must include sufficient information to verify that the washing machine is a model that is Energy Star certified.
- This rebate form must be turned into SEM CU within ninety (90) days of the purchase date to be honored.
- SEM CU may deny any application that does not meet all of the Program guidelines.
- Rebates shall be made on a first-come, first-served basis as long as program funding exists. No person making an application for a rebate shall be guaranteed or entitled to receive a rebate.
- SEM CU does not endorse, recommend, warrant or guarantee any appliance and is not responsible for the quality of items purchased.
- The program applicant agrees to hold harmless SEM CU and its directors, officers and employees from and against all loss, damage, expense and liability resulting from or otherwise relating to the purchase, installation use or removal of an appliance.
- By signing this form, the applicant has read and accepts the requirements and conditions of the rebate program. I declare that the foregoing is true and correct, and that I am the person named above, and I understand that any falsification of this form would result in the misuse of state of California funds, and may result in the refund of the rebate.
