- Corrections, Approval or Disposition – no changes
 - Jeff McGrath made a motion to approve the minutes
 - Jeff Evers seconded
 - all in favor

- Public Comments** – No public comments

Officer Reports

- Verlaine Elinburg, President
 - Verlaine talked about her duties to the community residents in attendance
 - She mentioned she works closely with the grant applications and the events around Madera that SEMCU participates in
 - She also mentioned SEMCU is working on the dry wells and she is gathering applications
- Jeff McGrath, Treasurer - Monthly Financial Report
 - Checking Balance: \$1,328.70
 - A \$350 installment for the RWMG dues was made
 - The Liberty High School golf tournament fundraiser of \$500 was made and Jeff Evers confirmed
 - Jeff made a motion for SEMCU to donate \$500 to the Liberty High School sober grad night. Jeff Evers second and all were in favor
 - The total applicants waiting to get reimbursed for Q1 2019 is 39
- Igal Treibatch, Secretary (not present)

Discussion Items

- RWMG Report from Al Solis (based on minutes as Al was not present)
 - Stephanie A proposed the formation of 2 educational groups, one mountain and one valley, to provide Q and A and troubleshooting services to residential well users
 - Jeannie H circulated a list of RWMG/IRWM tasks and duties for 2019
 - Prop 1 DAC funding is working with splitting the funds of \$11.7M available for implementation in the Mountain Counties
 - Jeannie H reported the Plan Update was rejected by the State
 - The SGMA report is due by the end of August and Stephanie A reported chapter one was being circulated
 - The next RWMG meeting will be on Monday, May 13th at 1:30pm at Chowchilla City Hall

- Grant Reports
 - Report from Owen Kubit
 - Owen reported we have finalized the 2014 grant report and we had to wait until final payments came in first
 - The tension should be released soon
 - We are still waiting for the 2016 grant extension, but it sounds like it will be approved
 - Owen will be working on finishing the next quarterly progress report soon

- Status of Dry Wells
 - Verlaine reported there are 12 applicants currently approved and ready for a dry well to be installed
 - Jeff McGrath explained the purpose of a dry well to the community residents in attendance and reiterated the importance of putting water back into the aquifer
 - Mark suggested getting a flood map from the county so we can identify what areas could use a dry well

- Upcoming Events – 2019 Flatlanders Parade
 - Verlaine mentioned we still have to come up with a theme for the float
 - The residents thought advertising the dry wells in some way would be a good idea
 - Verlaine said she could get a banner made that say 'FREE' for the float
 - Jeff McGrath made a motion to authorize Verlaine \$200 to get banners made for the float. Jeff Evers seconded, and all were in favor

 - Jeff McGrath said he will write next month's article as he was been taking down notes and points to talk about
